6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure

7. The school shall not deny admission to any child, -

- For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission
- On the ground of religion, caste or race, place of birth or any of them.

8. The school shall ensure that, -

- No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- No child shall be subjected to physical punishment or mental harassment.
- No child is required to pass any board examination till the completion of elementary education.
- Inclusion of students with disabilities/ special need as per provision of the *RTE 2009* (rule/ clause of State Act).
- The teachers are recruited with minimum qualifications as laid under *Basic Education Act 1973* (rule/ clause of the state Act).
- The teachers perform his duties specified under *Act 1973*. (rule/ clause of the state Act).

9. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

10. The school shall maintain the standards and norms as specified in *Act 1997* ... (rule/ clause of the state Act).

11. No unrecognized classes shall run within the premises of the school or outside in the name of school.

12. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.

13. The school is run by a society registered under the *Society Act 1860* (Act under with Society is registered), or a public trust constituted under any law for the time being in force.

14. The school is not run for profit to any individual, group or association of individuals or any other persons.


